Jaipur 16th August, 2021: Gravita India Limited, a leading recycling company having its manufacturing presence around the globe, is glad to inform that company has increased capacity of its existing recycling unit situated at Chittoor, Andhra Pradesh. The existing capacity of said unit of lead recycling has been increased by 10,200 MTPA and as on date the total capacity of this unit for lead recycling is 38,200 MTPA.
